



How many times have fellow Cataumet residents seen a truck smash into the Railroad bridge or the resulting wreckage? After attempting to manually raise the bridge (joking) several CCA Board members took the initiative to try and improve the signage on each side of the bridge with the intent to warn unwary truck drivers. Board Member Trish White contacted the Town of Bourne Roadway Traffic Safety Committee and communicated CCA's concern. She included photos of various mishaps

along with dates and times. The request to improve signage is now languishing at the town level.



"Non-Food" Drive

Last year, August 8th – August 20th, 2022, the CCA held its annual Non-Food Drive for the Bourne Food Pantry. This event is an opportunity for our village to help support about 700 Bourne residents with needed items which can't be purchased with their government benefits, such as pet food, hygiene products, paper goods, diapers, and wipes. Bins were left in front of the Depot and at the Cataumet Club for neighbors and friends to drop off any non food items. During the week the bins are checked throughout the day and items brought into the Depot, sorted and bundled. At the end of the week, we were pleased to have a car load full of non-food items, including cases of baby diapers, to deliver to the pantry. Many thanks to Jane Carroll and her family, and Trish White for making this happen by collecting, sorting, and delivering the items.





The Pantry also accepts money; each \$1 donated provides an estimated five meals to those in need. The Pantry can serve 30-50 families on any given day that they are open, more during the month of November and December. Now more than ever, with ever increasing costs of food and other necessities, Cataumet's contributions were much appreciated.

CCA plans to hold another Non-Food Drive this August, keep a lookout for our signs and bins. Please help make this event our best yet.

Bourne Rail Trail

As many of you may know, the plan to continue the Bike Path up to the canal has been in process for many years. Many agencies including the Friends of the Bourne Rail Trail and The Town (of Bourne) Administrator Advisory Committee of Pedestrian/Bicycle Pathway (TAACPB). The most current design shows that the Bike Path would actually run alongside the tracks and end at the RR Depot, emptying at the playground.

This design raised many concerns in regards to road and pedestrian safety, parking, and traffic. As a result, CCA committed to inform residents about not only the design but other details on a timely basis. In addition, CCA Board members contacted the AACPB and requested that another informational meeting be held by Zoom for all interested parties. CCA then advertised a special Zoom meeting on September 28, 2022. Close to 100 residents participated and voiced their multiple concerns. This meeting was the impetus in the decision to revisit the design which would remove the tracks and replace them with the bike path.

According to their website "The Friends (of the Bourne Rail Trail) have long promoted the construction of a "rail-to-trail" pathway, with the removal of the Falmouth Secondary and placement of the path in its stead. Until now, the Town has planned for a "rail-with-trail," where the path is built alongside the track. In March 2023, the Select Board voted unanimously to **pivot to the** "rail-to-trail" approach. If Commonwealth officials concur, the development of the project will be accelerated by decades at a significantly reduced cost."

In addition, on July 14, 2023, The Friends of the Bourne Rail Trail sent an email to many interested parties including CCA. This email was an urgent request to show a strong and unified support for removal of the Falmouth Secondary rail line and construction on the rail bed of the Bourne Rail Trail. The Friends of the Bourne Rail Trail asks residents to convince our elected officials that the public interest in a pedestrian and bicycle trail far outweighs the limited benefits of the relatively little used Falmouth Secondary rail line. This letter with accompanying instructions for contacting the State House can be viewed on CCA' website.

On behalf of CCA, I wish to thank all the people who took the time to become involved and speak up with many serious concerns.



The Case of the Missing Mail

It was the fall of 1980. My occupations at the time were house painting and commercial shell-fishing, the former I had been doing off and on since a teenager, and the latter for a few years. I also had an application in to the USPS specifically Pocasset, North Falmouth, and Cataumet locations. One day, while picking up my mail, then Cataumet Postmaster Alberta Harding called

me aside for an interview. Apparently, it went well as the next day she offered me a position. "Hmmm" I said "This sounds like a good opportunity as I live across the street and it would be steady work, but I love fishing for a living. Could I get back to you in a week or so?". She answered" You can get back to me tomorrow!". After due consideration and consulting with my

older brother, I decided to accept the job and thus began the start of a thirty two-year career with the Post Office.

I liked the job from the start. Alberta and I got along very well and quickly became friends as well as co-workers. In those days all mail was hand-cancelled using a nifty machine which I have in my possession to this day. You would line up the letters and use the

circular crank to run them through. The metal type would imprint them with the day, time, and year. One of the requirements was to change the date each day, much the way a newspaper typesetter does. Each day you change the date; each month the month; and on the first day of the new year; you would change to the new year. On the first day of business of 1981, I dutifully changed the year

from 1980 to 1981.

Business continued in the usual, routine fashion for a week or so until one day I noticed the cancellation was a little faint, indicating the need to put more ink on the pad. Upon examination of a sample piece, I noticed to my horror, a discrepancy. Now dear reader, I would like you to write 1981 on a piece of paper, then turn it upside down. I think you

will find it now reads 1861, as it did on ten days of mail originating at the Cataumet Post Office as a result of my putting it in upside down! To the public's and any postal inspector's eye all the past ten days mail was delayed by 120 years! With more than a little trepidation I brought this to Alberta's attention. "We'll just keep this to ourselves, don't you think?", and we did.
